- # All international students are required by the Malaysian authorities to have a Student Pass (with a validity of 1 year) or a Dependent Pass with Permission To Study Stamp prior to start school. SBIS will submit the application to Ministry of Education (MOE) for approval letter (for Student Pass) for a fee of RM250 per student per year.

### Conditions of Payment

1. A discount of 2% is applicable on the Tuition Fee upon payment of a full academic year fee prior to the commencement of new academic year.
2. 5% Sibling Discount of the Tuition Fee for the younger student will be given to all parents with more than one child in the school. The discount is subject to revision upon withdrawal of any sibling.
3. Payment can be made in cash, cheques, bank drafts, online transfer or major credit cards.
4. A late payment surcharge of 5% will be levied upon all outstanding fees.

# TERMS AND CONDITION FOR ADMISSION AND ENTRANCE EXAM

All parents/guardians are advised to read the policies and the terms and conditions stated below which governs the admission to Sri Bestari International School and the child's continued enrolment as a student of the School.

## Process and Criteria for Admission, Enrolment and Placement

1. A parent/guardian intending to enrol his/her child to the School must submit the completed and signed Application Form with the correct information. Any false, inaccurate or misleading information could lead to the rejection of the application or to the child's withdrawal from the School. The parent/guardian must inform the School of any changes to such information.
2. The School reserves the right to contact the previous school (if applicable and relevant) to obtain further information from medical officers or other relevant persons about the potential student for his/her admission.
3. The application fee (please refer to the fee schedule for details) is payable in full with each submission of the Application Form. The Application Fee covers an application for admission to the School for the Term and Academic Year applied for. The Application Fee is non-transferable and non-refundable regardless of whether the child is successfully admitted to the School or otherwise. The receipt of the Application Fee by the School does not oblige the School to assess and/or admit the child. The School has the final decision.
4. Once the application of the candidate has been submitted, the applicant will be required to undertake an Entrance Examination in curricular subjects:  
**Reception: Written assessment + Interview**  
**Primary Years: English and Mathematics + Interview**  
**Secondary Years: English, Mathematics and Science + Interview**  
**\*\*Applicants applying for Year 2 and above will require to also sit for the Bahasa Malaysia and Mandarin proficiency assessments.**
5. A new Application Fee will be imposed if any of the following occurrences:
  - An Application is withdrawn/stopped with/without an offer.
  - Parent/Guardian does not respond by the stipulated date to accept the offer.
  - Parent/Guardian is no longer in contact with the school at the last known address.
  - Any other terms and conditions not mentioned herein, governing Enrolment and Admission.

Re-Application Fee is applicable for any of the following occurrences:

  - An applicant requests to a different Entry Level
  - An applicant is unsuccessful the first time due to unsatisfactory assessment results.
6. The School generally takes into consideration various factors, including the child's age, academic ability, level of achievement relative to the School's current students and the child's behaviour. Hence, the admission and placement of the child is at the absolute discretion of the School. The School is not obliged to offer any justification for the rejection of any application.
7. The School also reserves the right to place the child in a class which the Head of School deems academically and developmentally fitting to the child's needs at anytime and from time to time whilst the child is enrolled at the School. This may include requiring the child to repeat one or more academic year(s).
